Note:

- The Council for Private Education (CPE) requires all students to be covered under the Fee Protection Scheme (FPS). SAA has adopted FPS with the CPE-appointed service provider, Lonpac Insurance Bhd. The insurance premium of the FPS is a minimum \$26.75 or 1% of course fee, whichever is higher, inclusive of GST. Local students pay this amount upon enrolment for 1 year of insurance coverage.
- For international students:
 - Fees payable upon application: Application fee S\$200 and ICA processing fee S\$30
 - Fees payable upon approval of Student's Pass: Tuition fees, Fee Protection Scheme S\$134.85 for 3 years of insurance coverage, Group Hospitalisation & Surgical Insurance S\$48.15 for 1 year of insurance coverage and a Student Development Fee S\$180
- Fees are subjected to revisions. University of London revises its fee on 1st Sept every year.
- Fees to SAA are inclusive of 7% GST at S1050 per UOL unit. ICPAS is a not-for-profit organization.
